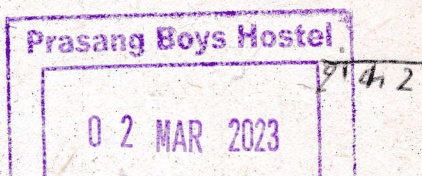


**Samriddhi College  
and  
Prasang Boys Hostel**

This contract ("Agreement") is made and entered into on the date of acceptance by Samriddhi College and by Prasang Boys Hostel, situated in Buddhanagar- New Baneshwor (hereinafter referred to as "Hostel"), and Samriddhi College (hereinafter referred to as "College"), for the purpose of setting forth the terms and conditions under which the Students from Samriddhi College shall be permitted to reside in the Hostel.

1. **Term of Agreement:** This Agreement shall commence on 21 Mangsir 2079 and shall continue until terminated by either party upon thirty (30) days written notice.
2. **Payment:** The Student shall be liable to pay to the Hostel a sum of Rs. 15000 Per month for Single seater, Rs. 11000 per month for the 2-seater Rs 10000 for four-seater duration of this Agreement. Payment shall be due on the first day of each month and shall be considered late if not received by the fifth day of the month.
  - 2.1 The hostel will provide a 6% subsidized rate to students referred and coming from the hostel. Students must pay one-time admission while setting up for accommodation registration.
  - 2.2 The admission charge for long staying students will be free, if not then Rs. 2000 will be charged as normal admission.
3. **Occupancy:** The Student shall be permitted to occupy/select a bed in a three-seater or two-seater-bed room in the Hostel. The student shall be responsible for keeping the room and common areas clean and orderly.
4. **Guest Policy:** The Student shall be permitted to have female guests in the hostel, but such guests shall be required to register with the Hostel upon arrival and shall be subject to the rules and regulations of the Hostel.
5. **Termination:** This Agreement may be terminated by either party upon thirty (30) days' written notice. Upon termination, the student shall have a choice either to continue or vacate the Hostel in a week.
6. **Post-Termination:** After termination of the agreement, if the student' referred from Samriddhi College remains at the hostel, meant that the student is a client of the hostel. The college shall not be liable to address any residential issues as obligations, except in good faith.





7. **Rules:** Students shall abide by the laws and regulations of the hostel and the college. Students shall be provided orientation to move to the hostel for the rules.
8. **Governing Law:** This Agreement shall be governed by the laws of the Government of Nepal.
9. **Food & Beverages:** The four times meal will be provided to the students. The Cyclic menu will be followed to cater the students.

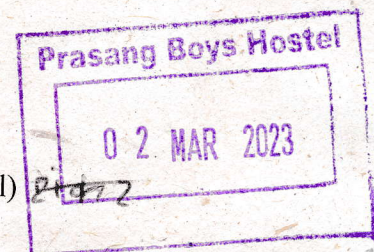

This contract ("Agreement") is made and entered into on the date of acceptance by Samriddhi College and by Palpali Girls Hostel, situated in Buddhanagar- New Baneshwor (hereinafter referred to as "Hostel"), and Samriddhi College (hereinafter referred to as "College"), for the purpose of setting forth the terms and conditions under which the Students from Samriddhi College shall be permitted to reside in the Hostel.

1. **Term of Agreement:** This Agreement shall commence on [21 Mangsir 2079] and shall continue until terminated by either party upon thirty (30) days written notice.
2. **Payment:** The Student shall be liable to pay to the Hostel a sum of Rs. 12,000 per month for the Double-Seater, Rs. 11,000 for Three-Seater and Rs. 10,000 for Four-Seater duration of this Agreement. Payment shall be due on the first day of each month and shall be considered late if not received by the fifth day of the month.
  - 2.1 The hostel will provide a 6% subsidized rate to students referred and coming from the hostel. Students must pay one-time admission while setting up for accommodation registration.
  - 2.2 The admission fee will Rs.2000 for the students.
3. **Occupancy:** The Student shall be permitted to occupy/select a bed in a three-seater or two-seater-bed room in the Hostel. The student shall be responsible for keeping the room and common areas clean and orderly.
4. **Guest Policy:** The Student shall be permitted to have female guests in the hostel, but such guests shall be required to register with the Hostel upon arrival and shall be subject to the rules and regulations of the Hostel.
5. **Termination:** This Agreement may be terminated by either party upon thirty (30) days' written notice. Upon termination, the student shall have a choice either to continue or vacate the Hostel in a week.
